#### 3.1 Description of the Assignment

The order value is not absolute in that sense that the assignment can be shortened or decreased in scope. Compensation shall therefore amount to worked hours, however the fee is not to exceed maximum order value without having this agreement extended.

#### 4.1 Overtime

eWork Standard. Overtime may only be charged if agreed in writing.

#### 4.2 Travel and Expenses

According to eWorks frame agreement with the Buyer.

In case travels and expenses may be charged, these shall be accounted for by submitting a clear expense report and of all receipts attached to the invoice. All documents must be marked with eWork's reference number 4523.

Travel time is not compensated, unless something else has been agreed.

### 5. Terms of Payment

The Consultant Supplier shall in accordance with the assignments agreed upon conditions account for worked hours and continuously provide eWork with billing documents as above. If nothing else is agreed upon accounting is done once per month. The accountancy is to be supplied to eWork no later than three (3) working days following the previous month-end. After receiving the time report, eWork will invoice the Buyer within three (3) working days. Payment from eWork to the Consultant Supplier shall be made within five (5) working days after obtained payment from the Buyer. The Consultant supplier is only entitled to payment in the extent that eWork has obtained payment from the Buyer.

Payment from the Buyer to eWork shall be made within 30 days net from the date of invoice.

For payment received after the due date interest may be charged in accordance with the Swedish Interest Act (1975:635).

2. The Buyer's standard terms. (Client's general terms and conditions for consultant services)
